Dear Chairwoman Donoghue and Chairman Wagner:

On behalf of the MACDC Board of Directors and Membership, we wish to thank you for your leadership of the Conference Committee for An Act Relative to Job Creation, Workforce Development and Infrastructure Investment (H.4483/S.2435), for reconciling the differences between the House and Senate bills, and for leading the way toward comprehensive economic development legislation. We are grateful that the House and the Senate adopted language to make a technical correction to the statutory language concerning the Community Investment Tax Credit (CITC) allocation formula (MGL Chapter 63, Section 38EE, (c) (4); MGL Chapter 62, Section 6M, (c) (4)). This revised language will give DHCD appropriate discretion to determine whether program participants are making adequate progress annually for dispensing with tax credits and will be less burdensome administratively for all parties involved in these activities. In addition to this important provision that improves the administration of the CITC program, both the House and the Senate versions of the economic development bill contain definitive language to provide \$45 million capital authorization for the Brownfields Redevelopment Fund, and \$6 million capital for the Massachusetts Food Trust.

We respectfully request that the Conference Committee adopt the following House and Senate provisions that will help to expand economic opportunity to families and communities across the Commonwealth:

- House-adopted amendment to authorize \$1 million capital funding for the Massachusetts Growth Capital Corporation (MGCC) to support a matching grant program for CDFIs and CDCs;
- Senate-adopted amendment to create a Donation Tax Credit (DTC) for affordable housing. This proposal would enable the existing State Low Income Housing Tax Credit (SLIHTC) to support more affordable homes, at no additional costs to the Commonwealth, by providing an incentive for owners to donate, rather than sell, their properties for use as affordable or mixed-income housing;



- Senate-adopted amendment to allow for the creation of Community Benefit
 Districts (CBDs), enabling collaborative public-private-nonprofit partnerships to
 implement local initiatives and to enhance community revitalization; and
- Senate-adopted amendment to increase the state Earned Income Tax Credit (EITC) from 23% to 28%.

The chart below offers a brief comparison of key economic-development priorities contained in the bills and that MACDC and its allies support.
